 - Senior Services.
 - Victoria Russo, Supervisor Family Support Program
 - Karen Kolb Flub, Manager of Family Support Programs for In-home and Support Services
 - Powerpoint presentation covering services. There are local, state, and federal resources. Chore help, companion volunteers, meal home delivery for food, food pick up, legal services, help with social isolation. Meal service 60 years old plus. Chore help for short term and long term need.
 - Caregiver support services up to \$250/yr. Respite services for caregivers up to 80 hours a year , 40 hr/per 6 months. Also, have caregiver training which is a 6 week program for 2 hours a week for a total of 12 hours. Don't have to live in the household with the person.
 - Help for Grandparents raising grandkids. Gap filling up to \$1000 of essential goods (55+age) for a child under 18.
 - Apartment manager training Feb 23rd 2-4 pm
 - Call 311 or 744-4016 to find resources and help.

- Neighborhood Development
 - Division Street Brown line El Stop Future
 - Jon DeVries, American Institute of Certified Planners
 - Presented the history of the 2009 Central Area Plan which identified the Division Ave Brown line stop as an opportunity for the community. Discussed the easement creation in relation to the Chicago Orleans Housing consortium. Land was donated for this easement. The estimated cost \$50-60 million dollars. Near North TIF extended 10 more years.
 - Line capacity issue needs to be addressed no northbound capacity constraint, can increase train platform and train length to increase capacity. There is a conceptual plan for a restored el stop.
 - Elimination of el stops in areas with public housing is a legacy racism issue. Damen ave. el stop as well as Cermack and Fulton show the impact new el stops have on neighborhoods. Including increasing housing density in area that support transit oriented development.
 - CHA estimates 2800 more units in area plus there is the proposed North Union development and concluding Atrium Village redevelopment. There is land from the Atrium development that has been allocated for an el stop.
 - John is a long time community advocate and professional certified planner that is retired.
 He still has association with Holy Family Lutheran church and Chicago Orleans housing.
